2025 Long Range Transportation Plan (LRTP)-

The long range plan identifies transportation projects that will be needed to support projected growth through the year 2025. The LRTP is not a funding plan, but a framework for future project selection. We are currently working on the development of the 2035 LRTP, with a tentative adoption date of December 2010.

Unified Planning Work Program (UPWP) - The UPWP details the work tasks to be undertaken during the year. Each task includes a description of the objective, previous work accomplished, work methodology, responsible agency, and funding sources.

Transportation Improvement Program (TIP)

- The TIP lists all capital transportation improvements programmed for the upcoming five years using Federal or State funding. An automated TIP is accessible through the TPO website.

Traffic Counts – Each year, the TPO monitors the traffic levels on major arterial and collector roadways in Brevard County. An interactive traffic count database is accessible through the TPO website.

State of the System Report - Throughout the year, TPO staff, FDOT and local governments collect and share roadway network data. This information is evaluated using performance measures, such as safety and congestion, to identify overall mobility trends in the area and to locate and rank congested corridors. This information is compiled and presented in the State of the System Report (SOS). The SOS is used as technical guidance for the TPO when determining project priorities each year.

Why should YOU get involved in the TPO process?

The TPO is made up of elected officials that represent you. They make decisions that will shape the future of transportation in Brevard County. These decisions can include road widening, new roads, transit routes and services, the location of sidewalks or trails, and policies regarding landscaping of roadways or other enhancements to the transportation system.

Who is the TPO?

The Space Coast TPO Board consists of nineteen (19) elected officials from Brevard County jurisdictions. The TPO Board has several advisory committees, that include a Technical Advisory Committee (TAC) made up of county, municipal and transportation agency staff, a Citizens Advisory Committee (CAC) made up of citizens appointed by the MPO Board, and a Bicycle/Pedestrian and Trails Advisory Committee (BPTAC). The TPO is also supported by a full-time staff, that include a Staff Director, Bicycle/ Pedestrian Safety Coordinator and Transportation Planner.

When does the TPO Meet?

The TPO Board holds regular Board meetings on the second Thursday of each month at 9:00 a.m. Agendas are available approximately two weeks prior to the meeting at the TPO Staff office or on the TPO web site. The TAC and CAC meet jointly at 10:00 a.m. on the Monday prior to the TPO meeting to make recommendations regarding items on the upcoming TPO agenda.
